Member and spouse must be 35 & under as of April 1 of current golf season and includes any children living with them age 17 and under.

**Senior** **\$1,600 / year or \$166.67 / month**

Member must be 75 years of age as of April 1 of current golf season.

---

**Limited** **\$2,050 / year or \$170.83 / month**

Member play is limited to Monday-Friday only (play not permitted on weekday holidays). Limited members may not participate in any weekday twilight league or in any tournament as a member.

**Young Adult – Ages 22-29** **\$1,710 / year or \$142.50 / month**

**Young Adult-New Member (30-34)** **\$2,340 / year or \$195 / month**

Members between the ages of 22 and 34 years as of April 1 of current golf season.

---

**College Student (Affiliated)** **\$600 / year or \$50 / month**

Member must be 18 years of age as of April 1 of current golf season and enrolled as a full-time student at an accredited college or university. An affiliated member must be the child or grandchild of a current full member.

**College Student (Unaffiliated)** **\$890 / year or \$74.17 / month**

Member must be 18 years of age as of April 1 of current golf season and enrolled as a full-time student at an accredited college or university.

---

**Junior – Ages 12-17** **\$525 / year or \$43.75 / month**

Member must be 12 years of age and not over 17 years of age as of April 1 of current golf season. An affiliated member must be the child or grandchild of a current full member.

---

**Child – Ages 8-11** **\$290 / year or \$24.17 / month**

Member must be 8 years of age and not over 11 years of age as of April 1 of current golf season. An affiliated member must be the child or grandchild of a current full member.

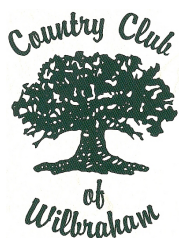

## Payment Agreement
