Individual Member **\$3,400 / year or \$283.34 / month**

Members age 35 and over as of April 1 of the current golf season

Family **\$5,600 / year or \$466.67 / month**

Member and his or her spouse - includes any children age 17 and younger living in same household

Couple **\$5,300 / year or \$441.67 / month**

Member and his or her spouse

35 & Under Family/Couple **\$3,400 / year or \$283.34 / month**

Member and spouse must be 35 & under as of April 1 of current golf season and includes any children living with them age 17 and under.

Senior **\$1,800 / year or \$150.00 / month**

Member must be 75 years of age as of April 1 of current golf season.

Limited **\$2,400 / year or \$200.00 / month**

Member play is limited to Monday-Friday only (play not permitted on weekday holidays). Limited members may not participate in any weekday twilight league or in any tournament as a member.

Weekend Premium Membership **\$ 3,000 / year or \$250.00 / month**

Play open in this class to Friday, Saturday, and Sunday only. Able to play in any Club Tournament open to membership

Weekend Membership **\$2,600 / year or \$216.67 / month**

Play open in this class to Saturday and Sunday play only. Able to play in any Club Tournament open to membership

Young Adult – Ages 18-29 **\$2,000 / year or \$166.67 / month**

Young Adult-New Member (30-34) **\$2,700 / year or \$225.00 / month**

Members between the ages of 18 and 34 years as of April 1 of current golf season.

College Student **\$700 / year or \$58.33 / month**

Member must be 18 years of age as of April 1 of current golf season and enrolled as a full-time student at an accredited college or university. An affiliated member must be the child or grandchild of a current full member.

Junior – Ages 12-17**\$625 / year or \$52.08 / month**

Member must be 12 years of age and not over 17 years of age as of April 1 of current golf season. An affiliated member must be the child or grandchild of a current full member.

Child – Ages 8-11**\$350 / year or 29.17 / month**

Member must be 8 years of age and not over 11 years of age as of April 1 of current golf season. An affiliated member must be the child or grandchild of a current full member.

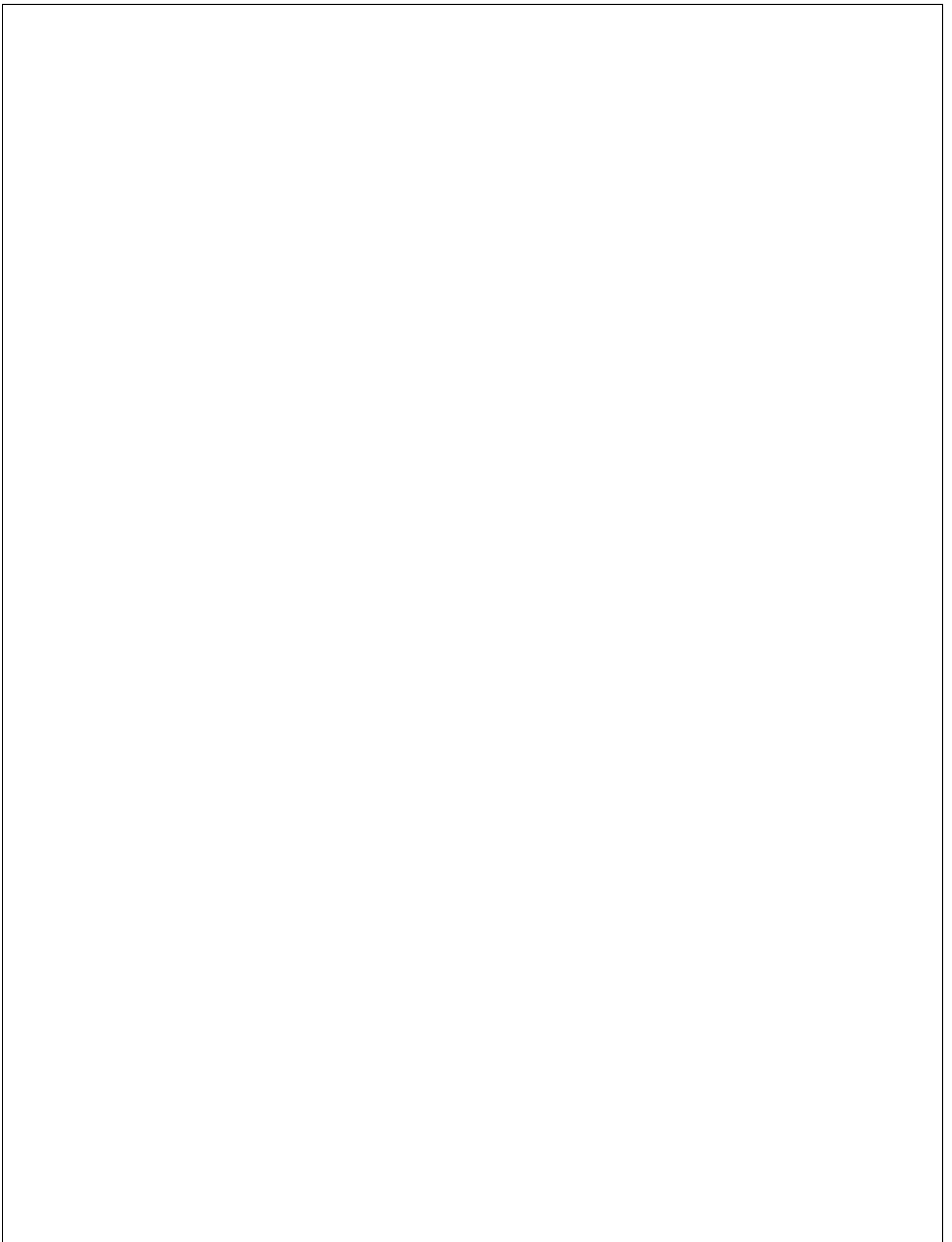
